# **QUESTION 1:**

Will GVB consider adding Route 14B (Paseo de Oro between South Marine Corps Drive to San Vitores Road) as part of IFB 2016-006?

GVB RESPONSE: No. This Invitation for Bid is for maintenance of the routes as specified in the Bid Schedule.

# **QUESTION 2:**

Can GVB consider reducing edging work along Route 1 (Southern Guam) from 6x/year to 2x/year?

GVB RESPONSE: No. Edging will occur as stated in the Bid

Schedule at 6x/year.

### **QUESTION 3:**

In consideration that most of the areas are overgrown and that it will take additional man hours to get it back to "reasonable height," can there be an addition to the initial scope of work to address this issue?

initial scope of work.

### **QUESTION 4:**

Will a final award be broken into two separate contracts?
