Re: Mandatory Customs Declaration Regarding the Importation of Items Related to COVID-

The Guam Customs & Quarantine Agency ("CQA") is hereby authorized to require the affirmative declaration of any importation of In Vitro Diagnostic Tests, Personal Protective Equipment ("PPE"), Medical Devices and Supplies, Anti-Toxins, Serums, Vaccines, Immunizing Agents, Antibiotics, other Pharmaceutical Agents and/or Ventilators. The exercise of this authority is imperative due to the need to ration supplies for the purpose of responding to the public health emergency, as well as, to prevent the importation of counterfeit items.

The exercise of this authority is imperative due to the need to ration supplies for the purpose of responding to the public health emergency, as well as, to prevent the importation of counterfeit items.

YOU ARE HEREBY NOTIFIED THAT ANY OF THE ABOVE LISTED ITEMS IS SUBJECT TO THE CONTROL, RESTRICTION, AND REGULATORY POWERS OF DPHSS AND MAY BE CONFISCATED. FALSE STATEMENTS MADE TO A CUSTOMS OFFICER ARE PUNISHABLE BY LAW. FAILURE TO DECLARE SUCH ITEMS TO A CUSTOMS OFFICER MAY RESULT IN FINES AND PENALTIES.
