

GVB SUSPENDS FREE TROLLEY RIDES

GVB has announced its free trolley service for island residents and visitors in Tumon will be suspended until further notice starting December 13, 2021. The reason for the suspension has to do with low rider turnout and changes in travel restrictions in Guam's source markets.

GVB had partnered with Lam Lam tours to provide the trolley rides at seasonal periods throughout 2021. The Guahan Trolley Service was offered daily between GPO and Micronesia Mall with multiple stops within Tumon through December 12.

"While the changes and restrictions due to the Omicron COVID variant have affected us around the globe, we believe this situation to be temporary. GVB will continue to monitor and adapt to the opportunities that emerging travel restrictions allow. We are optimistic over the return of the trolley service at a more advantageous time," said Dr. Gerry Perez, GVB Vice President.

VACCINATION CLINICS





ARRIVAL PROTOCOLS

AMENDED ORDER: INTERNATIONAL TRAVEL



The CDC has introduced [new requirements](#) for international travelers to the United States effective as of December 6, 2021.

All air passengers two years or older arriving in the United States from a foreign country at or after 12:01 a.m. EST on December 6, 2021, are required show a negative COVID-19 viral test result taken no more than 24 hours before travel, or documentation of having recovered from COVID-19 in the past 90 days, before they board their flight. This change applies to all air travelers.

On December 02, 2021, The Centers for Disease Control and Prevention (CDC) within the Department of Health and Human Services (HHS) amended its October 25, 2021 Amended Order, titled, "Requirement for Proof of Negative COVID-19 Test or Recovery from COVID-19 for All Air Passengers Arriving in the United States." This amendment updates COVID-19 testing requirements for air passengers 2 years or older boarding a flight to the United States.

TRAVEL RESTRICTIONS BY MARKET

JAPAN

- The Japanese government does not distinguish between vaccinated and unvaccinated travelers for entry requirements
- All arrivals, regardless of nationality are subject to 10-day quarantine (except business traveler)
- Secure negative certificate 72 hours prior to departure; airline to verify; test again *upon arrival*
- Download 3 apps on smartphone* (MySOS, Google Maps and COCOA) * *Traveler will be required to rent a smartphone if they do not own one*
- For Japanese nationals who have negative result in both tests, they are requested to 10-days self-quarantine at home
- Guam residents who has US passport holders are subject to 10-day quarantine, which is the the same restriction as for Japanese nationals
- The three-day quarantine scheme for vaccinated business travelers upon arrival went into effect on November 8
- Japanese government accepted the vaccination certificate issued in 82 countries and regions

SOUTH KOREA

- All travelers to South Korea must provide proof of a negative PCR test result collected within 72 hours of their departure
- As of May 5, those fully vaccinated in South Korea can bypass quarantine; as of Aug 30, PCR test required on Day 1 and Day 6/7 of arrival
- Those not fully vaccinated in Korea must undergo 10-day home quarantine; PCR tests required on day 1 and day 12/13 of arrival
 - Those vaccinated overseas must undergo 10-day home quarantine; PCR tests required on day 1 and day 8/9 of arrival
- Korean nationals arriving without a negative PCR test will be required to undergo a 7-day quarantine at a government facility at their expense (\$120/day), followed by 7 days of home quarantine
 - Korean nationals arriving without a negative PCR test will be denied entry. If the test result submitted is found to be invalid after arrival, the traveler will undergo a 5-day quarantine at a government facility at their expense (\$120/day), followed by 5 days of home quarantine
- Foreigners arriving without a negative PCR test will be denied entry
- Children under the age of 6 may be exempted from the negative PCR test result requirement and quarantine if all of the accompanying persons traveling with children have vaccinated and submitted valid negative PCR test results
- Korean resident who receives their first dose in Korea and receives their second dose on Guam are able to bypass quarantine upon arrival in Korea if they register and get 2nd dose of vaccination certificate from the local public health center in Korea. (if no registration/issuance, no quarantine exemption)

TRAVEL RESTRICTIONS BY MARKET

TAIWAN

- Requires a negative PCR test 72 hours prior to departure
- Fill out electronic health declaration form prior to departure via Quarantine System for Entry @ <https://hdhq.mohw.gov.tw>
- Travelers are required to make an affidavit stating that the location of their intended **14-day** quarantine in Taiwan meets relevant regulations
- All travelers will be quarantined for 14 days with the following exceptions: Taiwan tourists who participate in the Palau Travel Corridor program only need 5 days enforcement self-health monitoring + 9 days self-health monitoring (individual is not allow to take any public transportations in this period)
- 7+7: those who have received the second dose of a COVID vaccine at least 14 days prior to arrival will be able to reduce their hotel or quarantine center stay to 7 days, while the remaining 7 days can then be spent at their place of residence

PHILIPPINES

- All nationals/Filipinos, including spouse and children (Filipino/ foreign), foreign crew members, foreign government and international organization officials accredited to the Philippines and foreign nationals allowed under relevant IATF resolutions are permitted entry to the Philippines
- Effective 6 December 2021, those who fail to present a negative RT-PCR test before travel will be not accepted on flights to the Philippines

Yellow List

All other countries not specified as "Green" or "Red"

Effective December 3, 2021, the following testing and quarantine protocols for arriving international travelers in all ports or entry coming from countries/territories/jurisdictions not classified as a Red List country/territory/jurisdiction under IATF Resolution 151-A (s.2021) shall be observed.

Vaccinated

- Negative RT-PCR test result taken within 72 hours prior to departure
- Facility based quarantine until release of negative results
- 5th day swabbing
- Home quarantine until 14th day from arrival

Unvaccinated, Partially Vaccinated, Unverified

- Negative RT-PCR test result taken within 72 hours prior to departure
- Facility based quarantine until release of negative results
- 7th day swabbing
- Home quarantine until 14th day from arrival

NOTES:

- The testing and quarantine protocols of **Minors** shall follow the testing and quarantine protocol of the parent/guardian traveling with them, regardless of the minor's vaccination status, and country of origin.
- International passengers who have already arrived and are currently undergoing quarantine, shall continue with the testing and quarantine protocols in place at the time of their arrival.

All arriving travelers from green or yellow country, 5 or 7-DAY QUARANTINE IN GOVERNMENT FACILITY, DEPENDING ON VAX STATUS

- 10 days: \$1,000 USD
- 7 days: \$700 USD*
- PCR test: \$70 USD

Quarantine cost varies based on hotel; prices are estimates in the mid-range. GUAM is on yellow list.









KOREA'S PUSH FOR BRINGING NORMAL LIFE BACK MARRED BY OMICRON, SOARING CASES



- Korea's three-month plan for exiting pandemic restrictions is being threatened by a record surge in infections and the likely community spread of the omicron variant.
- However, the government remains that Korea will continue to commit to restoring normal life amid the growing backlash from front-line health care workers.



S. KOREA ORDERS STRICTER IMMIGRATION MEASURES TO BLOCK OMICRON

- President Moon Jae-in ordered the government to immediately implement stricter immigration quarantine measures to block the inflow of the omicron variant.
- He then called for the rapid establishment and implementation of quarantine strategies as well as the development of a diagnostic kit to detect the omicron variant as soon as possible.

SINGAPORE AND SAIPAN EXEMPTED FROM QUARANTINE WITH TRAVEL BUBBLE



- The government has decided to exempt quarantine to inbound travelers from countries that have signed travel bubbles such as Singapore and Saipan.
- However, there is a possibility that the travel bubble may be temporarily suspended in consideration of the quarantine situation in each country.

JAPAN TO BAR ALL NEW FOREIGN VISITORS AS OMICRON FEARS GROW



- Japan will ban all incoming foreign travelers for one-month, effective Nov 30, in an effort to prevent the omicron variant from spreading domestically.
- New restrictions will encompass all new entries — including foreign exchange students, interns and those traveling for business — from every country in the world.



US TRAVEL RESTRICTIONS: TIGHTER TESTING REQUIREMENTS IN PLACE

- The Biden Administration said that all travelers aged 2 and over flying to the U.S. would need to show proof of a negative Covid-19 test taken within a day before their flight.
- This new time frame applies to everyone, regardless of nationality or vaccination status, from December 6.

AUSTRALIA TO PAUSE NEXT PHASE OF BORDER REOPENING AMID OMICRON FEARS



- Australia will pause the reopening of its international borders amid growing concerns of the Omicron variant, pushing back to December 15.
- The country was expected to reopen to international skilled and student cohorts, as well as humanitarian, working holiday maker and provisional family visa holders from December 1.

S. KOREA REINFORCES ITS SOCIAL GATHERING RULES



- South Korea will slightly change its COVID-19 related rules which conforms to the previous fourth level of social distancing rules for 4 weeks starting from December 6.

GOV'T DECIDES NOT TO MOVE TO NEXT PHASE OF 'LIVING WITH COVID-19' PLAN

- The country will not move to a second phase of "Living with COVID-19" due to the coronavirus resurgence and hospital bed shortages, and instead remain in the current first stage for four more weeks along with "special quarantine measures."
- Tightening the cap of participants at private gatherings or visitors to restaurants and cafes is also being discussed.



Vaccination & Booster Shots

- People aged between 18 and 49 will get booster shots after five months as well
- Recommendation of children aged between 12 and 17 to be vaccinated



Home Treatment

- Home treatment to be default to deal with the shortage of hospital beds for coronavirus patients
- Temporary treatment centers at regions will be established for the patients whose condition get worsens



Vaccine Pass

- A limited validity of six months after the last inoculation to encourage more people to receive booster shots

<SPECIAL QUARANTINE MEASURES>

AIRPORT SCREENING IS BACK, QUARANTINE MEASURES AMID 1ST OMICRON CASE CONFIRMATIONS

- South Korea decided to reimpose strict passenger screening at airports, mandatory quarantine to prevent the spread of the emerging omicron variant of COVID-19 after reporting the first such cases in the country.



All Inbound Passenger

- All international arrivals will be required to undergo mandatory quarantine for 10 days until December 16 starting from December 3, regardless of whether they are vaccinated.
- PCR test: **Total of 3 times**
 - ✓ Before departure to Korea, Day 1, Before released from quarantine



Quarantine

- South Korean citizens and foreigners on long-term stay will be allowed to quarantine at home.
- Foreigners on short-term stay will have to be quarantined at a temporary facility designated by the government.

- Kyowon KRT has launched a luxury travel Ahead of the Good Choice Company's new launch of the overseas travel market, it opened a new lottery promotion, where the first prize winner can travel to Guam.
- The promotion consists of two-person packages and are scheduled to depart on next January, which will be the first outbound customers of Good Choice Company.

UNVACCINATED TRAVELERS INCLUDING CHILDREN BARRED TO ENTER THE CNMI FROM DECEMBER 1

- Marianas Visitors Authority urgently announced that the government has initiated an emergency measure that restricts entry of unvaccinated travelers upon entry from December 1, 2021.
- This announcement was based on the recent local infection in the Northern Mariana Islands, especially among the children.



Protocol

Entry restriction to all unvaccinated travelers including children accompanied by vaccinated parents

7 days quarantine at the government-designated quarantine facility

MARIANA ISLANDS TO SUPPORT TRAVELERS IN JANUARY 2022

- Saipan has decided to extend its travel support for travelers until next January in order to relieve financial burden amid the pandemic.
- Earlier this week, Mariana Islands announced entry restriction to all unvaccinated travelers including children accompanied by vaccinated parents.

LEVEL 2 COVID ALERT EXTENDED TO DEC. 13

Taiwan's Central Epidemic Command Center (CECC) on Monday (Nov. 29) announced that the Level 2 COVID-19 alert currently in effect will be extended to Dec. 13.

The COVID-19 situation in Taiwan has continued to slow down since the pandemic alert was lowered from Level 3 to Level 2 on July 27.



CECC chief Chen Shih-chung said at Monday's COVID-19 briefing that disease prevention measures pursuant to the Level 2 alert will mostly remain unchanged for the extended period. However, he said large-scale activities set for Christmas and New Year's with lots of overseas arrivals call for stricter measures and punishments.

NIGHTTIME VACCINATION BEGINS; PX MART VACCINE SITES CONSIDERED

A number of hospitals in Taiwan have begun offering nighttime COVID-19 vaccination slots from Thursday, while the Central Epidemic Command Center (CECC) is also considering setting up vaccine sites at PX Mart supermarkets in an attempt to boost Taiwan's COVID-19 vaccine coverage.

Hospitals set up by Taiwan's Armed Forces, Ministry of Health and Welfare, and Veterans Affairs Council will offer slots for people to get vaccinated in the evenings, CECC spokesperson Chuang Jen-hsiang said at a press briefing Thursday.

People interested in getting vaccinated can make reservations through the government's 1922 vaccine platform or contact the hospitals directly, Chuang said.



The CECC is also considering setting up vaccination sites at PX Mart supermarkets after the company reached out to the CECC on Thursday, Chuang said.

TAIWAN BUYS ADDITIONAL 5 MILLION AZ DOSES, DETAILS BOOSTER SHOT RULES

Taiwan signed a contract with AstraZeneca in November to purchase 5 million doses of the company's COVID-19 vaccine for the rollout of booster shots, Minister of Health and Welfare Chen Shih-chung said Thursday.

The doses will be delivered in the coming year, and Taiwan will have the option of choosing between AstraZeneca's first and second-generation vaccines, Chen added.

Taiwan signed a contract with Moderna in July to purchase 35 million doses of the company's next generation vaccine, 20 million of which are scheduled to be delivered in 2022.

Taiwan is also holding talks with BioNTech about purchasing its second-generation vaccine, Chen said Thursday.

Also on Thursday, Chen announced that Taiwan would begin its rollout of COVID-19 booster shots at noon for certain categories of people who received their second shot at least five months ago.



LUNAR NEW YEAR QUARANTINE RULES UNCHANGED DESPITE OMICRON CONCERNS

Loosened COVID-19 quarantine protocols for travelers entering Taiwan ahead of the Lunar New Year holiday will remain unchanged despite concerns over the Omicron variant, the Central Epidemic Command Center (CECC) said Wednesday.

The Omicron variant, first discovered in South Africa, was designated as a "variant of concern" by the World Health Organization on Nov. 26 and has since been detected in nearly 20 countries.



Due to the variant's mutations, there are concerns it could be more transmissible compared to previous strains of the virus and that it may reinfect those previously infected with COVID-19 more easily.

When asked whether the eased quarantine protocols for Lunar New Year holiday travelers would continue if an Omicron case was confirmed in Taiwan, Health and Welfare Minister Chen Shih-chung said no.

HEALTH MINISTER DETAILS INITIAL COVID-19 VACCINE BOOSTER SHOT RULES

- Health Minister Chen Shih-chung on Tuesday provided more details on COVID-19 booster vaccine shots after the Central Epidemic Command Center (CECC) announced a day earlier the rollout could start as early as Jan. 1, 2022.
- Chen said that while the general public will be allowed to choose a preferred vaccine as a booster shot, the CECC advises against mixing-and-matching the two mRNA vaccines -- Moderna and Pfizer-BioNTech.
- He encouraged those who have been inoculated with two jabs of Moderna or BioNTech to get the same vaccine as a booster.
- When it comes to the AstraZeneca (AZ) vaccine, Chen said after being asked by reporters about the issue that although there are a significant number of documented cases of adverse effects when mixing-and-matching a third dose of mRNA as a booster after receiving two AZ jabs, the symptoms are generally mild.
- As such, Chen said the CECC will recommend the AZ and mRNA mix-and-match option to prospective recipients, while adding that three AZ doses is also an option.



TAIWAN LISTS 4 MORE AFRICAN COUNTRIES AS HIGH-RISK DUE TO OMICRON

- The (CECC) Central Epidemic Command Center has placed six countries in Southern Africa on its high-risk list due to the appearance of a new, heavily mutated variant of COVID that has surfaced in South Africa.
- During a press conference on Monday (Nov. 29), Health Minister and CECC head Chen Shih-chung announced that due to a rise in the Omicron COVID variant in Africa, four more countries on the continent will be deemed high-risk starting Dec. 1. Chen said that visitors from all countries deemed to be high-risk must undergo quarantine in a quarantine center, and they will not be eligible for the shortened hotel quarantine during the Lunar New Year.
- The four latest countries on Taiwan's high-risk list include Egypt, Malawi, Mozambique, and Nigeria. These now join South Africa, Botswana, Namibia, Lesotho, Eswatini, and Zimbabwe already on the list, bringing the total to 10.

TAIWAN COVID-19 NEWS



- On December 1, Due to the new coronavirus variant Omicron is spreading globally, CECC announced that travelers who have visited the four countries in the last 14 days (transits included) will be required to quarantine in group quarantine facilities for 14 days after arrival and to undergo PCR tests (upon checking in and at the end of quarantine) for COVID-19; they will also be required to practice an additional 7-day self-health management (a COVID-19 rapid test using a home test kit on the sixth or seventh day).
- Such travelers will not be required to pay group quarantine facility accommodation and testing fees, and the 7+7+7 and 10+4+7 quarantine programs for the Lunar New Year don't apply.
- The list of "key high-risk countries" currently includes the following ten countries: South Africa, Botswana, Namibia, Lesotho, Eswatini, Zimbabwe, Malawi, Mozambique, Egypt, and Nigeria (the last four countries are newly added).
- The latest list of the risk categories for countries/regions is as follows:
 - Level 1 (Watch): None.
 - Level 2 (Alert): Palau.
 - Level 3 (Warning): The rest of the countries/regions in the world except for Palau.
- CECC announced foreign workers will be allowed to enter Taiwan under a Ministry of Labor program provided that related pandemic prevention measures should be followed. (Nov. 11)
- In response to influx of inbound travelers before Lunar New Year holiday, CECC adjusts quarantine measures.
- On November 11, CECC announced the "7+7" policy for travelers who have been fully vaccinated against COVID-19 for at least two weeks before their arrival in Taiwan. Under the policy, which will be in place from Dec. 14, 2021 to Feb. 14, 2022, travelers will spend the first seven days of quarantine in a government facility or designated hotel, and then spend the remaining seven days of quarantine at home.

PHILIPPINES SUSPENDS DECISION TO ALLOW VACCINATED TOURISTS ENTRY

The Philippines has temporarily suspended a decision to allow fully vaccinated tourists entry in a bid to prevent a new, heavily mutated variant taking off in the country where most of the population remains unvaccinated. It comes as the Southeast Asian nation launched a three-day vaccination drive targeting nine million people as young as 12 in an effort to accelerate the roll-out of jabs.

Manila recently announced plans to allow fully vaccinated tourists from most countries to enter from Dec. 1 as it seeks to revive the nation's battered economy. The government's COVID-19 task force reversed course as it announced the suspension of flights from seven European countries, in addition to an earlier ban on arrivals from several African nations.

The decision is a major blow to tourism operators across the nation, which have been devastated by a plunge in international visitors and restrictions on domestic travel since borders shut in March 2020. Tourism is a major driver of the country's economy, accounting for nearly 13 percent of gross domestic product in 2019, when more than eight million people visited, official data shows. That slumped to 5.4 percent last year as tourist arrivals plummeted 82 percent to 1.48 million.

The government has eased virus restrictions in recent weeks as the daily infection rate hovers at the lowest level since the beginning of the year and the nationwide vaccination rate increases. But the emergence of omicron has raised fears curbs could be reinstated.

DUTERTE EXPECTS PH TO REACH COVID-19 VAX GOALS BY YEAR-END

With the launch of the country's three-day nationwide vaccination drive, President Rodrigo Duterte expects the Philippines to achieve its vaccination target before the end of the year. "By the end of 2021, we expect to fully vaccinate a total of 54 million Filipinos; we also aim to inoculate 80 percent of the population of minors aged 12 to 17 years; and complete the booster shots for those belonging to A1, A2, and A3 sectors," Duterte said in his speech during the launch of the three-day national vaccination event, dubbed "Bayanihan, Bakunahan."

The program, which ran from November 29 to December 1, aims to vaccinate around 9 million individuals in 8,000 sites across 16 regions nationwide. Duterte described the event as the country's "single biggest push" to fast-track vaccination and reach its goals.

During the event, Duterte led the ceremonial simultaneous vaccination of individuals under A1 to A4 categories and pediatric 12-17 age group.

The A1 category refers to workers in frontline health services; A2 category refers to senior citizens; A3 category refers to persons with comorbidities; and the A4 category refers to frontline personnel in essential sectors including uniformed personnel.



PHILIPPINES TIGHTENS BORDER CONTROLS TO KEEP OUT COVID-19 OMICRON VARIANT

On November 28, the Philippines further tightened border controls to keep out the new Omicron variant of the coronavirus, adding seven European countries to a travel ban that initially covered seven African nations.

The Philippines coronavirus task force placed Austria, Czech Republic, Hungary, The Netherlands, Switzerland, Belgium and Italy under its "red list" until Dec 15, banning the entry of travelers from these countries. The ban initially covered South Africa, Botswana, Namibia, Zimbabwe, Lesotho, Eswatini, and Mozambique.

The government also backpedaled on a plan to allow the entry of some vaccinated foreign tourists starting Dec 1. "Inbound international travel of all persons, regardless of vaccination status, coming from or who have been to red list countries/jurisdictions/territories within the last 14 days prior to arrival to any port of the Philippines, shall not be allowed," acting Presidential Spokesperson Karlo Nograles said in a statement.

NEW DEAL WITH PFIZER SIGNED FOR 20 MILLION MORE VACCINE DOSES

The Philippine government has signed a new deal with the US vaccine manufacturer Pfizer-BioNTech for the purchase of another 20 million COVID-19 doses, according to vaccine czar Carlito Galvez Jr. Galvez said the additional Pfizer COVID-19 vaccine doses will be used as booster shots and to vaccinate more minors in the country.

"With these additional doses, we can ensure the sustainability of our National Vaccination Program, and hit the vaccination targets we have set not only for this year, but for 2022 as well," Galvez said in a virtual briefing for media.

The additional 20 million Pfizer COVID-19 vaccine doses will be delivered to the country starting in January 2022. The procurement of the fresh Pfizer vaccine doses will be financed through the Philippines COVID-19 Emergency Response Project loan secured by the national government from the World Bank last March.



GOVT EYES GIVING BOOSTERS TO A4, A5 PRIORITY GROUPS ON DEC 10

Government and economic front liners, as well as indigent Filipinos who have completed their COVID-19 shots within the last six months may get their booster dose as early as December 10, according to vaccine czar Carlito Galvez Jr.

Galvez also said in a virtual presser that the government wants to start administering booster doses for the A4 group by Dec. 10, especially for those who got their second shot beyond six months. He added that those in the private sector may proceed with their booster inoculation during that time to help the government get closer to its inoculation target.

Currently, only healthcare workers, senior citizens, and people with weakened immune systems (immunocompromised) — classified as priority groups A1 to A3 — are allowed to get boosters.
